Environment Protection is a practice of protecting the nature environment on individual organization controlled or governmental levels, for the benefit of both the environment and humans due to the pressures of over consumption, population and technology, the biophysical environment is being degraded, sometimes permanently. This has been recognized and governments have begun placing restraints on activities that cause environmental degradation. Since the 1960s, activity of environmental movements has created awareness of the various environmental issues.

An environmental organization is an organization coming out of the conservation or environmental movements that seeks to protect, analyse or monitor the environment against misuse or degradation from human focus. The organization may be a charity a trust, a non governmental organization or government organization.

Noble global environmental organization are the United Nations Environment Programme (UNEP) World Wide Fund for Nature, the Intergovernmental Panel on Climate Change (IPCC), World Nature Organization (WHO), Greenpeace and Friends on Earth.

The organization has four areas in which it operates: Government Policy, Field Work, Partnerships and science. Partnerships are made with the US government, the European Union and other foreign governments to preserve and conserve natural resources.

The conservation fund in Arlington has protected more than 7 million acres of land in all 50 states. With a mission of saving land for future generations, the fund considers its "win-win" philosophy of balancing environmental and economic interests to be what sets it apart from other groups.

### **Notable Achievements of UNEP**

UNEP has registered several successes, such as the 1987 <u>Montreal Protocol</u> for limiting emissions of gases blamed for thinning the planet's protective ozone layer, or the 2012 <u>Minamata Convention</u>, a treaty to limit toxic mercury.

UNEP has sponsored the development of solar loan programs, with attractive return rates, to buffer the initial deployment costs and entice consumers to consider and purchase solar PV systems. The most famous example is the <u>solar loan program</u> sponsored by UNEP helped 100,000 people finance solar power systems in <u>India</u>. Success in India's solar program has led to similar projects in other parts of the developing world like <u>Tunisia</u>, <u>Morocco</u>, Indonesia and Mexico.

UNEP sponsors the Marshlands project in the <u>Middle East</u>. In 2001, UNEP alerted the international community to the destruction of the Marshlands when it released satellite images showing that 90 percent of the Marshlands had already been lost. The UNEP "support for Environmental Management of the Iraqi Marshland" commenced in August 2004, in order to manage the Marshland area in an environmentally sound manner.

In order to ensure full participation of global communities, UNEP works in an inclusive fashion that brings on board different societal cohorts. UNEP has a programme for young people known as Tunza. Within this program are other projects like the <u>AEO for</u> Youth

Founded in 1987, the organization states the importance of nature for climate, air, water, food, and resource purposes; however, economic and infrastructure development is also stressed as crucial to what it terms human well-being. Conservation International's work comes in as bridging the gap between these two interests through sustainable development. The organization has four areas in which it operates: government policy, field work, partnerships, and science. The organization also partners with local communities, scientists, NGOs, and corporations to work in 40-plus countries, especially those it designates as priority areas. In late June, Conservation International earned agency status from the Global Environment Facility, the biggest public funder of environmental projects in the world.

As its range of activities broadened, the international organization believed that its name no longer reflected the scope of its activities and became the Worldwide Fund for Nature in 1986. But the affiliated groups in the United States and Canada retained the original name. The organization is now simply, referred to as WWF.WWF-India is committed to protecting and saving the already degraded and threatened natural bounties in the country. The organization is today dedicated to the conservation of natural habitats and ecosystems in India.
